Call for tenders No. 17-110517-A relating to the Initial Transition to Static and Dynamic Data (SDD) Operations – Support to EAD Data Providers

The purpose of this Call for Tenders is to seek for a provider with the aim to procure expertise and support for the European AIS Database (EAD) system in the field of AIS/AIM Dynamic Data.

Background:

EUROCONTROL, the European Organisation for the Safety of Air Navigation, is an intergovernmental Organisation with 41 Member States, committed to building, together with its partners, a Single European Sky that will deliver the air traffic management performance required for the twenty-first century and beyond.

Within EUROCONTROL, Network Manager Directorate (NMD) delivers the network manager functions and services at Pan-European level, thus supporting civil and military customers in their obligation to meet their objectives in general and specifically those applicable under the SES II performance regime. The NMD Work Programme is an integral part of the ATM value chain aimed at delivering performance, in particular safety, capacity and flight efficiency.

Within the NMD organisation, the EAIM Unit is responsible for the EUROCONTROL EAD (European AIS Database) Service and the oversight of Information Management function with the following objectives:

- a) Managing and developing the EAD Service to support the Network Manager, FABs, ANSPs, Users and international stakeholders;
- b) Ensuring the availability and completeness of aeronautical data including airspace data for the delivery of the Network Manager Operational functions;
- c) Ensuring the correctness, consolidation and formalisation of data, required by the Network Manager function with respect to aeronautical information, airspace, and other associated data including archived data.
