
With RP2 due to run until end of 2019, we are fast approaching a new era of RP3. ATM will continue to be driven by performance but there are trade-offs between cost-efficiency, capacity, safety and environment and security. These goals may be in competition with one another individually, but even when there is a common goal there is competition for resources. What resources should we look at in the future? How much should we focus on our assets or strengths as well as deficits or weaknesses? There are new threats but also new opportunities...

We will hear from ANSPs on going public and the potential impact on safety. We will hear the customers' point of view and discuss expectations from the perspective of airspace users. Moving toward RP3, we will discuss the challenges and outlook with a panel of CEOs. What will the KPAs and dependencies be? One crucial emerging issue that we all need to understand is cybersecurity. One of the world's foremost experts will give a talk on this: Prof. Chris Johnson (Glasgow University). Finally, issues connected to the increasing complexity of the ATM world will conclude the event.

The intent of this event is to hear from you and the safety issues and challenges that concern you the most. Naturally, the Network Manager, EASA and the airlines are also part of the equation and their voices need to be heard. Thus, we are inviting you to share your safety experiences and set out how you intend to meet these challenges in particular in the context of the on-going second reference period and the upcoming third reference period.
